

### July 2016 Residential Sales

The following Real Estate statistics were collected by MLSOK, Inc., for the time frame **July 1**, **2016 to July 31**, **2016**. Below summarizes our regions monthly sales activity. For a full review please see report that follows.

### Months' Supply of Inventory (MSI) Decreases



The total housing inventory at the end of July 2016 rose **2.10%** to 7,716 existing homes available for sale. Over the last 12 months this area has had an average of 1,746 closed sales per month. This represents an unsold inventory index of **4.42** MSI for this period

### **Average Sale Prices Going Up**



According to the preliminary trends, this market area has experienced some upward momentum with the increase of Average Price this month. Prices went up **4.64%** in July 2016 to \$198,462 versus the previous year at \$189,668.

### **Average Days on Market Shortens**



The average number of **50.42** days that homes spent on the market before selling decreased by 3.34 days or **6.21%** in July 2016 compared to last year's same month at **53.76** DOM.

### Sales Success for July 2016 is Positive



Overall, with Average Prices going up and Days on Market decreasing, the Listed versus Closed Ratio finished weak this month. There were 2,998 New Listings in July 2016, down **4.46%** from last year at 3,138. Furthermore, there were 1,952 Closed Listings this month versus last year at 2,211, a **-11.71%** Decrease.

### Months Supply of Inventory (MSI) Increases

The total housing inventory at the end of July 2016 rose **2.10%** to 7,716 existing homes available for sale. Over the last 12 months this area has had an average of 1,746 closed sales per month. This represents an unsold inventory index of **4.42** MSI for this period.

### Median Sale Prices Going Up

According to the preliminary trends, this market area has experienced some upward momentum with the increase of Median Price this month. Prices went up **4.38%** in July 2016 to \$167,000 versus the previous year at \$160,000.

### **Median Days on Market Shortens**

The median number of **24.00** days that homes spent on the market before selling decreased by 0.00 days or **0.00%** in July 2016 compared to last year's same month at **24.00** DOM.

### Sales Success for July 2016 is Positive

Overall, with Median Prices going up and Days on Market decreasing, the Listed versus Closed Ratio finished weak this month.

There were 2,998 New Listings in July 2016, down **4.46%** from last year at 3,138. Furthermore, there were 1,952 Closed Listings this month versus last year at 2,211, a **-11.71%** decrease.

Closed versus Listed trends yielded a **65.1%** ratio, down from last year's July 2016 at **70.5%**, a **7.59%** downswing. This will certainly create pressure on an increasing Month's Supply of Inventory (MSI) in the following months to come.
