#### **Analysis Wrap-Up**

#### Months Supply of Inventory (MSI) Decreases

The total housing inventory at the end of October 2014 decreased **14.14%** to 6,928 existing homes available for sale. Over the last 12 months this area has had an average of 1,699 closed sales per month. This represents an unsold inventory index of **4.08** MSI for this period.

#### Median Sale Prices Going Up

According to the preliminary trends, this market area has experienced some upward momentum with the increase of Median Price this month. Prices went up **8.35%** in October 2014 to \$154,340 versus the previous year at \$142,450.

#### **Median Days on Market Shortens**

The median number of **34.00** days that homes spent on the market before selling decreased by 6.00 days or **15.00%** in October 2014 compared to last year's same month at **40.00** DOM.

#### Sales Success for October 2014 is Positive

Overall, with Median Prices going up and Days on Market decreasing, the Listed versus Closed Ratio finished strong this month.

There were 2,445 New Listings in October 2014, up **6.86%** from last year at 2,288. Furthermore, there were 1,814 Closed Listings this month versus last year at 1,605, a **13.02%** increase.

Closed versus Listed trends yielded a **74.2%** ratio, up from last year's October 2014 at **70.1%**, a **5.76%** upswing. This will certainly create pressure on a decreasing Month's Supply of Inventory (MSI) in the following months to come.
