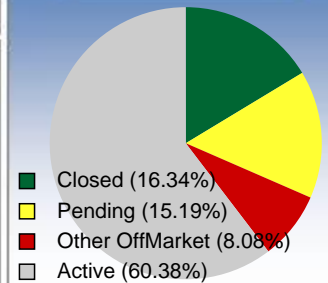

Analysis Wrap-Up

Months Supply of Inventory (MSI) Decreases

The total housing inventory at the end of September 2015 decreased **11.67%** to 6,931 existing homes available for sale. Over the last 12 months this area has had an average of 1,766 closed sales per month. This represents an unsold inventory index of **3.92** MSI for this period.

Median Sale Prices Going Up

According to the preliminary trends, this market area has experienced some upward momentum with the increase of Median Price this month. Prices went up **3.03%** in September 2015 to \$160,000 versus the previous year at \$155,300.

Median Days on Market Shortens

The median number of **27.00** days that homes spent on the market before selling decreased by 4.00 days or **12.90%** in September 2015 compared to last year's same month at **31.00** DOM.

Sales Success for September 2015 is Positive

Overall, with Median Prices going up and Days on Market decreasing, the Listed versus Closed Ratio finished weak this month.

There were 2,650 New Listings in September 2015, up **8.92%** from last year at 2,433. Furthermore, there were 1,876 Closed Listings this month versus last year at 1,881, a **-0.27%** decrease.

Closed versus Listed trends yielded a **70.8%** ratio, down from last year's September 2015 at **77.3%**, a **8.43%** downswing. This will certainly create pressure on a decreasing Month's Supply of Inventory (MSI) in the following months to come.
